An individual on a student visa is immediately eligible to begin on-campus employment as soon as the semester begins, and no waiting period applies. The employment assignment ends as soon as the student changes or loses F-1 status or graduates from the University.

In general, you can work a maximum of 20 hours per week during the academic year and a maximum of 35 hours per week during the summer and when classes are not in session.

17-month extended OPT period, if the employer participates in the E-Verify program (Pace University does participate) . It is added to the existing 12 months of OPT period that is available to all qualifying F-1 students. This provides a total of 29 months of OPT.
